### **European Association for Biometrics founded**

Today the European Association for Biometrics has been established. During the inaugural meeting on 17<sup>th</sup> November 2011 the founding members, representing 14 institutions from 10 different European countries, have chosen the founding members of the Management Board. The board members are all seasoned and well respected individuals from the European biometrics and identity community:

The EAB, having its legal base in The Netherlands, is a non-profit organization seeking to advance the proper and beneficial use of biometrics in Europe and abroad, taking into account the interests of European citizens, industries, academia and operators, including governments. Alexander Nouak, chairman of the EBA says:

Unlike existing or previous initiatives the EAB is a European multi stakeholder platform run by its members to the benefit of all."*

- Research and programme development

The EAB is a direct spin off from the BEST Network, a European Commission funded thematic network on biometrics (DG INFSO, FP7 ICT-PSP, contract nr. 238955, [www.best-nw.eu](http://www.best-nw.eu), EC project officer: Mr. Oluf Nielsen).

#### EAB Vision

The need for **understanding and exploiting** the current and emerging technologies and services for the automated recognition of human identity is of increasing importance to the economic and social welfare and deserves a concerted, multidisciplinary and sustained effort. **The European context**, with its unique diversity, interdependence, heritage and values creates special requirements and opportunities for the development of such biometric technologies and services to maximise the benefit for the citizens and to protect society from any possible adverse side effects. The European Association for Biometrics **envisions** and strives for a future where biometric and allied technologies are used **in the service of Europe and for the benefit of all**.

The work programmes of these committees are currently being designed and will be announced at the European Biometrics Symposium (Brussels, February 17<sup>th</sup> 2012), the public inauguration of the EAB.
